Introduction

2002-02-17: Early minutes are hand written and poor legibility is indicated by (?) some crossing out by XX initially and later, where legible, by strike outs, and inserts above the line by ^.

The layout and style is similar to the minute book with commas and capitals being inserted in non-standard places but the handwritten indentations that vary from page to page have been only approximately followed. Minutes of meetings follow on in the original book but in the copies here each meeting starts with a new page.

It is odd that for several years the minutes were hand written and seem to have been written in the meeting and not written up as a fair copy even though a typist was employed at £78 per annum (something like £15,000 a year at today's prices) but read on.

The hand written minutes seem not to have been written by the Secretary as the writing changes quite frequently.

The first few meetings have the minutes numbered i.e. meeting 1,2,3 but that feature was stopped after a few meetings. In another organisation of similar age it is known that meetings have been numbered since the start of meetings. Perhaps, when all the minutes have been found, the Society would like to reinstate the system. At four meetings a year for 90 years that gives meeting 360 by 2002 but we may be up to significantly more than that.

These copies have not been proof read and may not be exactly as the originals.

2002-02-26: From 1911 onwards the paragraphs are typed up with an indent at the beginning of all paragraphs and a line space between each paragraph. The hand written minutes are non-standard but there seems to be no point in copying the exact hand style. Spellings are original and punctuation is original. Crossings out have also been shown.

Notable items in the minutes.

In September 1908, Dr Andrew Carnegie gave SSS £1000 (which would have been a huge sum at that time).

In November 1911, the committee agreed to publish a newsletter called the Pioneer. Our 4 copies of Pioneers are 1917–1918.

In December 1911 there was a request for women to be admitted to the councils. This was agreed and several ladies were appointed.

May 1912. H G Wells gave permission for a story to be transcribed by the society. We do not have this text, but the first paragraph is used in Personal Views.

In 1913, the minutes were presented in reformed spelling. Throughout the minutes, there are occasional proposals, discussions and votes by members on isolated words or phonemes, but no mention of a complete scheme.

23 March 1937 includes a mystifying reference to a Patch Simplified Spelling Society.

**Minutes of the meeting held in the York Room,
Holborn Restaurant, on Thursday 10 th September,
1908.**

Dr Furnivall, having called the meeting to order moved that Professor Skeat do take the chair. Carried by acclamation.

The chairman moved that Mr. Archer be asked to act as Secretary for the time being. Agreed.

The Chairman made an opening statement mentioning the difficulties that had been encountered in former years by the, scholars who had urged a simplification of English Spelling. It was now proposed to make a renewed effort to overcome these difficulties by means of a Society which should co-operate with the Simplified Spelling Board of New York, but should adapt to English conditions its constitution and its methods of propaganda.

Dr Scott, on behalf of the Visiting Committee of the American Board, said that that board felt that the cause would be greatly advanced by the establishment of a similar organisation in England, and Professor Bright added that it quite noticed(?) that the details of method found advantageous in one country might not be equally suitable in the other.

Professor Jevons thought that the usual English method of procedure was rather to form a Society with an Executive Committee than to constitute a board and thereafter to appeal for adherents.

Professor Gollancz enquired as to the status of those gentlemen present who were not members of the existing Simplified Spelling Board of the U.S.A. It being agreed that the meeting as a whole should consider itself a Provisional Committee, Professor Gollancz urged that the proposed Society should not tie itself down in its style and title to a policy of simplification, but should adopt a name importing a dispassionate interest in the problems of spelling, rather than any settled conviction as to the need for reform. He proposed as a title the "English Spelling Society".

Dr Furnivall & several others opposed this view and a general discussion ensued.

Finally Dr Furnivall moved (and Professor Jevons seconded) :-

"That the persons now present be invited to form a Committee to establish a Simplified Spelling Society in the United Kingdom."

Professor Gollancz moved (Mr. Monro seconding) the amendment that the word "English" be substituted for "Simplified".

A vote being taken the amendment was negatived by 7 votes to 2, and Dr. Furnivall's motion was carried nem. com., Professor Gollancz refraining from voting.

All those present with the exception of Professor Gollancz having accepted the invitation to form a Committee, Professor Jevons read the following draft:-

Constitution and rules of the Simplified Spelling Society

1. The name of the society shall be "The Simplified Spelling Society".
2. Its objects shall be to recommend simpler spellings of English words than those now in use, to further the general use of such simpler spellings by every means in its power, and to co-operate with the Simplified Spelling Board of the United States of America, founded and incorporated in New York.
3. All persons shall be admissible as members of the society without distinction of sex or nationality.
4. Every member shall pay a subscription of at least one shilling per annum, which shall entitle him to the receipt post free of the Society's publications.
5. A person shall be deemed to have become a member of the Society when he has notified the Hon. Secretary in writing of his desire to become a member, and tendered the amount of one year's subscription, and the Hon. Secretary has notified him of his admission to the Society. The acceptance of any person as a member of the Society shall not be delayed longer than one calendar month from the date of his application, unless the committee by formal resolution, has refused him admission, which course they shall be entitled to take without assigning any reason.
6. A general meeting of the Society shall be held annually in the month of June, at which Reports shall be presented, and the officers for the ensuing year elected.
7. The Hon. Secretary may arrange for the holding of general meetings of the Society at other times for any purpose of which the Committee may approve; and the Hon. Secretary can be required to Call a special General Meeting thirty days after receiving a requisition signed by not less than 50 members of the Society.
8. There shall be a President and not less than three Vice-presidents, an Honorary Treasurer, & an Honorary Secretary. The President, the Hon. Secretary, together with not less than nine other members, shall form the committee.
9. The officers shall hold office for one year but be eligible for re-election. The ordinary members of the Committee shall be elected for three years, one third retiring each year but being also eligible for re-election.
10. The Officers and Committee for the ensuing year shall be elected at the annual General Meeting. The President and Vice-Presidents shall be nominated by the committee; but any member of the Society shall have the right to nominate any other member for the officers of Hon. Treasurer and Hon. Secretary, or ordinary membership of the committee.

11. The Hon. Secretary shall have the assistance of a paid secretary to be styled "Assistant Secretary"
12. The committee shall have power to make payments for any work done for the Society

Dr. Furnivall moved (Professor Bright seconding) "That the preceding rules be adopted as the rules of the Society subject to modification. Carried unanimously.

Dr. Furnivall moved (Professor Jevons seconding)
"That Professor Skeat be elected President of the Simplified Spelling Society".
Carried unanimously.

The following gentlemen were then elected as Vice presidents:-

Mr. Andrew Carnegie (proposed by Dr. Furnivall , seconded by Mr. Archer).
Dr. Furnivall (Proposed by Mr. Archer, seconded by Professor Jevons).
Sir J.A.H. Murray (Proposed by Professor Bright, seconded by Dr. Furnivall)
Dr. Henry Bradley (proposed by Dr. Furnivall seconded by Dr. Scott).
Professor James W. Bright (proposed by Dr. Furnivall seconded by Professor Jevons).

It was arranged that the next meeting of the Committee should be held at University College, on Friday the 18th of September at 8 p.m.

The Proceedings closed with a vote of thanks to the Visiting Committee of the Simplified Spelling Board, moved by Professor Gollancz, and seconded by Dr. Furnivall. A suitable response was made by the members of the Visiting Committee.

Minutes of the Second Committee Meeting held at University College, Friday, 18 th September, 1908

The President, Professor Skeat, was in the chair. Of the Provisional Committee formed at the previous meeting there were present Mr. William Archer, Professor James W. Bright, Dr. J. H. Furnivall, Mr. J. J. Munro, Dr. Charles P. G. Scott.

The minutes of the previous meeting were read and passed.

The Chairman moved (Dr. Furnivall seconding) that rule 4 should read (?) as follows:-

Every member shall pay an entrance fee on one shilling, and a subscription of at least one shilling per annum. Due on the first of January in each year, which shall entitle him to the receipt, post free, of the Society's publications. Carried.

Professor Bright moved (Dr. Furnivall seconding) "that throughout the Rules, the word "Honorary" before the word "Secretary" and 'Treasurer' should be omitted. Carried.

Professor Bright moved (Dr. Furnivall seconding) "that Mr. William Archer be invited to accept the office of Secretary and Treasurer". Carried. Mr. Archer consented subject to a fuller discussion of the situation with the Committee to be eventually constituted.

Professor Bright moved (Dr. Scott seconding) "that in accordance with the practice of The Simplified Spelling Board, the Secretary be invited to nominate, subject to the approval of the Committee, the assistant Secretary and other assistants, as may from time to time be deemed necessary. Carried.

Mr. Archer moved (Professor Bright seconding) an addition to rule 8: "The vice Presidents shall not be ex officio, but may be elected members of the committee." Carried.

Dr. Furnivall moved, (Professor Bright seconding) "that rule 12 should run as follows: 'The Committee shall have full control over the policy, conduct and finances of the Society.'" Carried.

Some other amendments having been informally discussed, the Secretary suggested that he be empowered to prepare before the next Committee meeting a revised draft of the rules in accordance with the views expressed. Agreed.

The Chairman moved that the following gentlemen be invited to form (along with the ex officio members), the Committee of the Society:-

It was agreed that the gentlemen should be approached with a view of obtaining their consent.

Mr. Monro asked what was now the position of the Provisional Committee formed at the previous meeting. It was agreed that on the nomination of the regular committee, the Provisional Committee ceased to exist.

Dr. Scott asked for an informal expression of approval of the proposition made by Professor Loundsbury, President of The Simplified Spelling Board, that a joint committee of experts should be appointed to consider and report upon the scientific basis for the Simplification of English spelling. Without taking a vote the Committee accepted in principle this proposition.

Dr. Scott also enquired what was the feeling of the Committee, with regard to the Advisory Council, whether a separate Advisory Council should be formed for the United Kingdom, or whether the existing council should be regarded as common to both Societies, the British members to be nominated by the "Simplified Spelling Society.

The Committee was understood to favour the latter arrangement.

The next meeting of the Committee was fixed for Friday, October 2nd, at 4.30 p.m., at University College.
October 2nd 1908

Minutes of the third Committee Meeting held at University College, Friday, October 2nd, 1908, at 4.30 p.m.

The President, (Professor Skeat) was in the Chair.

The minutes of the previous meeting were read and passed.
The Secretary then read the following letter from Mr. Andrew Carnegie, covering a cheque for £ 1000.

Dear Mr. Archer,

I enclose a check for one thousand Pounds Sterling, according to my promise to Mr. Scott, with copy of a letter which I sent to him. I make no further promises, because everything depends upon results. Frankly, we expect some work to be done in the old home.

Mr. Scott would tell you that the great state of Iowa has adopted the 600 words as proposed by the Board, and these are used in every State Institution from the State University to the Public School.
This is progress.

I congratulate you upon the eminent men with whom you are surrounded, and shall watch anxiously your doings. I hope you will send me copies of all documents issued, so that I may keep in touch. We are marching rapidly on the other side and the dear old home is either to join the procession and march, or be left behind.

My dear Mr. Scott,

I am glad to hear that the Britons are going to form a Society, but I do not wish to be considered as going to furnish all the funds needed, being satisfied that nothing would retard the progress of the cause more than the Knowledge that it was the work of an alien. I can only be one of the subscribers. Please make this point clear.

If there had been but one organization, then my fund given in America might have been drawn upon to some extent without injuring the cause, but a separate British Society, supported by an alien would never do.

The President moved, and Dr. Furnivall seconded the following resolution:-

"That the thanks of the Society be offered to Mr. Andrew Carnegie for his generous donation to its funds; and that Mr. Carnegie be assured of the determination of the Committee to apply its resources to the active prosecution of the ends for which the society has been founded, among them being that of cordial co-operation with The Simplified Spelling Board of America"

The resolution was carried unanimously, and the Secretary was instructed to communicate it to Mr. Carnegie.

Dr. Furnivall stated that of the Committee nominated at the previous meeting five had consented to serve, namely:-

Two had declined, namely Mr. W.A. Craigie, and Professor W.P. Ker(?). From Dr. Henry Bradley, Sir J. A. H. Murray and Professor Joseph Wright, no reply had been received.

It was proposed seconded and carried that the following five gentlemen be invited to join the committee:-

Mr. E Chambers (of University College),
Dr. Frank Heath,
Dr. Gilbert Murray M.A. LL.D.,
Dr. Trechmann,
Dr. H.C. Wild;

various members of the committee undertook to communicate with these gentlemen.

The position of the office-bearers then came up for consideration. Mr Archer urged that the officers of Secretary and Treasurer should be separated; and, Dr. Furnivall having consented to act as Treasurer, Mr. Archer moved (Professor Jevons seconding):-

"That the Treasurer (Dr. J. J. Furnivall) be instructed to open an account for the Society at the London and County Bank, 111 New Oxford Street, and that all cheques shall be signed jointly by the Treasurer and the Secretary (Mr. William Archer). Carried.

Mr. Archer then reminded the committee that at the previous meeting he had accepted the Secretariatship subject to a fuller discussion of the Situation than was then possible. He now stated that, although he had plenty of useful propaganda work to be done, he felt so strongly the urgent necessity for a practical (as distinct from an historical or scientific) survey of the whole situation, that he could not throw himself with conviction into the work of propaganda, unless this survey was undertaken at the same time. He proposed therefore that he should be commissioned to draw up such a survey, to be submitted to the Committee and, if approved by them, to be offered as a basis for their deliberations to the International Commission of Experts which, it was hoped, would one day examine and report upon the whole question. He suggested that the committee should allot him £ 50 over and above his salary as Secretary, it being understood that if he found himself unable to execute the work as he conceived it he should report to the committee to this effect, & the proposed payment should not be made.

A general discussion ensued. Several members doubted the usefulness of the proposed survey, and Mr. Archer confessed that only by executing it, could he make his idea quite clear. At the same time he disclaimed all thoughts of suspending or slackening the work of propaganda while the survey was being carried out.

Eventually, Professor Jevons moved (Dr. Furnivall seconding) that Mr. Archer's proposal be agreed to, subject to the proviso, that the proposed survey should be submitted to the Committee within six months. Mr Archer having promised to do his best to fulfil this condition, the motion was carried.

The Secretary then submitted the following provisional budget for the coming year:-

The last two items in the above list are Special Expenses, which would not recur in an annual budget. The permanent expenses in rent and salaries on the scale above would be £ 545.

After some discussion Dr. Furnivall moved (Professor Jevons seconding) that the Budget be passed. Agreed.

The Secretary having been commissioned, at the previous meeting, to nominate the Assistant Secretary, he now nominated Mr. W.W. Skeat, and the nomination was ratified by the committee.

The secretary presented a report as to possible offices, & it was agreed that No. 44, Great Russell Street, would be a suitable situation, if the rooms were found otherwise suitable.

The draft Constitution and Rules drawn up since last meeting was revised & further amended, & the Secretary was instructed to produce at the next meeting a fair copy of the Rules in their amended form.

An understanding was arrived at that members of the Committee residing at a distance from London, & having to make special journeys to attend committee meetings, shall be entitled, on sending the Treasurer a note of their travel expenses, to have them refunded.

Dr. Furnivall proposed (Professor Jevons seconding) that the names of Professor Thomas R. Loundsbury, LL.D., the Right Hon. James Bryce, and Dr. T.J. MacNamara be added to the list of Vice-Presidents. Carried.

No date was fixed for the next committee meeting.

Minutes of a meeting held at 44, Great Russell Street, on 9 th November at 5.30 p.m.

Present: Dr. Furnivall

It was agreed that the minutes should be read at the next meeting.

The Secretary reported the progress that had been made with regard to securing subscribers & otherwise forwarding the objects of the Society.

Prospectuses had been sent out to:-

246 London and Provincial Papers
901 Members of the English Association
45 Enquirers
152 Persons believed to be more or less sympathetic, the names being mainly taken from a list furnished by the American Board, & by Mr. H. Drummond, of Hetton-le-Hole.

Notices had appeared in about 45–50 papers.

The life members numbered 33 (or 29, deducting members of the Committee), and included Professor Dowden, Professor Mackail, Sir T. Clifford Allbutt, Sir Edward Clarke K.C., Lady Welby, Sir Charles Eliot (Vice-Chancellor of Sheffield University), Professor G. Moore Smith, Professor of English at Sheffield, and Mr. Oldfield Thomas, of the Natural History Museum, the subscriptions sent varying from 12/- to £ 5.

The number of ordinary members who had joined was 40, the subscriptions varying from 1/- to £10.

The Secretary further reported, with regard to the proposed Simplifications, that no return had been made by Dr. Heath.

The Secretary then read a digest of the remarks made by those who had returned the list of proposed simplifications.

Mr Westlake suggested (on the conclusion of the report), that *ur* should be substituted for or in the *-our* class of words.

Mr Westlake further proposed that "s" should be substituted for *-ce* in such words as *licorice*. *and this was carried. (Note 2002. Added later).*

The Committee decided that "throu" was the best ~~form for~~ way of spelling "through".

The consideration of the report having been concluded, Mr. Westlake agreed that it was essential to have a carefully thought-out scheme of phonetic values, in consonance with which alone all changes should be made. This scheme he undertook to draw up himself, & to forward to the Secretary.

No date was fixed for the next meeting.

Minutes of a meeting held at 44, Great Russell Street, at 4.30 pm. on Dec. 22 nd 1908

Present: Dr. Furnivall
Mr Pollard
Mr W. Archer

The minutes of the previous meeting were read and confirmed.

The Secretary gave information as to the increase of the numbers of members, (both life and ordinary members), & of the subscriptions received to date.

The Secretary ~~reported~~ gave information as to the amount expended.

He then announced that the Rt. Hon. James Bryce had accepted the offer of Vice-Presidency.

A letter from Mr. J. S. Westlake, Dated 19 th Dec. 1908, was read, ~~it was resolved that the~~ in which he put forward the following motion.

" That the Society advocate no reform which would work in a direction counter to that phonetical system adopted by the Classical Societies for the revised pronunciation of Latin, or would run counter to the current general pronunciation of the Latin vowels by Latin nations".

Resolved: that the letter be put on the minutes, & that when changes were being made, the principles set out in it should be borne in mind, but that the Society be not in any way definitely bound thereby.

A letter from Mr. Joseph Knowles, asking for advice as to the adoption of a system of spelling for the benefit of the Illiterates in India, was laid before the board.

Resolved that Mr. Knowles be advised to apply to the authorities of the International Phon- ~~System~~-Society, the matter being left however in the hands of the Secretary.

The Secretary next read a list of pamphlets already in hand, & explained that what may be called for brevity sake the "etymological argument" could easily be worked up further from the recent article in "Mod. Language Teaching". With regard to the Times Reader he recommended that it should be reprinted with marginal notes, in accordance with Mr. Andrew Carnegie's own suggestion.

The Secretary suggested that if size and price permitted copies of Dr. Lounsbury's recent book on Spelling Reform (~~2002 illegible deletion in original~~) should be procured for circulation. He considered it probable that the book would contain the substance of Dr. Lounsbury's article in the Atlantic monthly called "Confessions of a Spelling Reformer".

Mr. A.W. Pollard suggested that the President should be requested to edit about 8 or 9 pages of some standard author in normalized spelling.

This was agreed to.

It was further agreed that the Secretary should propose a digest of press opinions and submit them to the Committee with a view to their possible publication.

Minutes of a meeting held at 44, Great Russell Street, at 4.45 p.m. on 11 th February 1909

The Secretary read the minutes of the last meeting which were approved.

The Secretary reported a falling off in the response made to circulars sent out since the last meeting. The last 12000 copies of the prospectus had been sent to members of the College of Preceptors.

The Question of the advisability of sending out pamphlets in company with the prospectus was discussed.

It was suggested that five hundred copies of the prospectus should be sent out with, and five hundred without the pamphlets [approved.

The Secretary reported the gist of a letter from Mr. Gaston, suggesting that a circular be issued to urge publishers not to insist upon the fashions of English Spelling in books printed in America & sent across in stereo-plates. After some discussion, it was resolved that the proposed letter be sent, if approved by the President and signed by both the President and the Secretary.

Mr. H. Stanley Jevons urged the circularising of all English and Scotch University Professors & Lecturers : approved.

The Secretary reported that on the advice of Dr. McKay, about 87 Newspapers, Professors and Lecturers in Canada had been circularised. Mr. H. Stanley Jevons brought forward and explained his scheme for an alfabet with consistent values, based upon the principle of accepting the commonest accepted English values (ignoring the finer distinctions).

The Secretary moved that Mr. Jevons be requested to continue the work upon his scheme, as an important preliminary piece of work preliminary to the work of the proposed Joint-Committee.

Dr. Furnivall suggested that the scheme should be printed for the use of the Committee. After discussion, it was agreed that typed copies should be made for circulation amongst the members of the Committee.

The Secretary brought to notice an essay by Dr. Andrews upon the use of the final -e. Agreed that the secretary should write and suggest some method of publication other than ~~that~~ as one of the pamphlets of the S.S.S.

The Secretary mentioned a letter from Mr. Percy Simpson, suggesting that several papers of Howell's English Grammar, published in 1662, would be worth reprinting, together with a passage in Epistle(?) Ho-Eliane(?). Mr. Archer was authorised to write and ask Mr. Simpson to put them into a form suitable for printing.

Mr. Stanley Jevons moved that there should be established some regular procedure or rules for dealing with the questions of simplification to be adopted.

After much discussion Mr. Jevons moved:-

The secretary reported that out of ninety nine members to whom notices had been sent reminding them that their second year's subscription was due, sixty had paid. Agreed that the same system should be pursued with regard to subscriptions falling due in the current half year.

The Secretary then read a statement of the present position, & explained that he had sent copies of it to members of the committee who were unlikely to attend, & that only Mr Jevons had replied, suggesting the promotion of an active campaign.

It was agreed however that active steps should be postponed until the results of Professor Rippmann's scheme had been ascertained. The Secretary then read the draft of his letter in reply to Mr. Carnegie, and this letter was amended and approved.

The Secretary explained the steps that he proposed to take in order to economise expenditure pending the possibility of starting a more active campaign: these were that the salary of the Secretary & that of the corresponding Secretary should respectively be reduced from £ 200 to £ 100 per annum, ^ the reduction to take place after the end of the March quarter it being understood that they should divide between them the duty of attendance at the office.

This was agreed to.

The minutes of the previous meeting were read and agree to.

A resolution was unanimously adopted expressing the deep regret of the Society for the loss of its Treasurer Dr. Furnivall one of the pioneers of Simplified Spelling in England.

On the motion of the Secretary, seconded by Professor Gilbert Murray, Professor Rippmann was asked, & consented to accept the office of Treasurer, in succession to Dr. Furnivall.

The Secretary then read a report as to the number of members who joined the Society during the first six months of 1909, & who had renewed their membership for the current year.

It appeared that 69 applications for renewal of membership had been sent out & that 36 second subscriptions had been received — only a little over 50 %. Subscriptions had not been received from 63 Canadian Members, but would doubtless be collected by Mr. Dearness(?) in due(?) time.

The Secretary reported that the Rippmann-Archer "Proposals for a Simplified Spelling of the English Language" had been communicated to all members of the Committee, only two of whom (Professor Murray and Mr. Westlake) had made any comments upon it. (The comments of the President, it should be noted, are contained in the pamphlet itself). It had further been communicated to Sir Frederick Pollock, Sir William Ramsay, & Mr. Daniel Jones, all of whom had criticized it in detail, but expressed themselves generally favourable to it. Some discussion took place on Mr. Westlake's suggestion that in any such scheme the values assigned to the vowels ought to be the Latin or Continental values. He looked forward to a time when a universal alphabet would be adopted by all civilised nations, and thought that no reform should be sanctioned which would lead us away from this ideal.

The Committee then considered the criticisms

for each meeting attended, & that the out-of-pocket expenses of members resident outside London should be defrayed.

The Secretary made a financial statement showing that at the beginning of 1911 the Society would have a balance of over £ 100 on its current account at the Bank, together with a deposit of £ 800.

A letter was read from Professor Skeat expressing his wish to retire at the end of the year from the office of President. The Secretary was instructed to convey to Professor Skeat the sincere regret of the Committee and to urge him to reconsider his decision.

A letter was read from Mr. W.W. Skeat requesting that from January inst. His salary should stand at the rate of £ 150 a year in place of £ 100 at present. It was agreed that this rise should be granted until further notice and pending the developments to be anticipated after the conference.

There were present: Miss Gavin, Mr. Stanley Jevons, Mr. Daniel Jones, Mr A.W.Pollard, and Mr. William Archer. Mr Stanley Jevons was voted to the Chair.

The Hon. Secretary read a letter from Miss Burstall, M.A. of the Manchester High School for Girls, in which she accepted the invitation of the Committee to become a Vice-President of the Society. It was reported that Miss Cleghorn, the President of the N.U.T., had deferred her decision until she was able to give fuller study of the subject; and that Miss Faithfull, of Cheltenham, had arranged a lecture at her college & would give her decision later. Miss Bryant had declined for the present.

The Hon. Secretary reported that the following new members had been enrolled since the last meeting of the Committee: 1 Life Member, 7 Full Members, 11 Associate Meetings (*sic*). Lectures in Harrow, Leeds, Bristol, Worthing, Glasgow, Ealing, Cheltenham & Durham had been arranged. It was agreed that a payment of one guinea per lecture should be made to lecturers authorised by the Society to address minor gatherings (literary societies, and so on) on the subject of Simplified Spelling. It was understood that a member of the Committee, or an officer of the Society, would, if possible, ~~hear~~ be present at the first lecture in such cases.

The question of printing and distributing leaflets advertising the lectures to be given in the various provincial centres was left to the officers of the Society.

A discussion took place in regard to the proposed formation of local branches of the Society. It was agreed that the Secretary draw up a leaflet containing suggestions for the working of local branches & submit it to the Committee. The opinion was expressed that the lectures already arranged might become a kind of missionary centre in each place; the interested might be asked to remain at the close of the lecture & form themselves into a local branch, appointing a local correspondent whose name would appear on the letter paper of the Society. The Secretary was asked to write to Mr. J. Dearness, of London, Ontario, and advise him that Canadian branches of the Society would be allowed to retain half the amount of the subscriptions paid by the members; such money to be applied to local propaganda. It was decided that the same terms should apply to South India and South Africa.

The Secretary was instructed to convey the thanks of the Committee to Dr. Trechmann for his work in transcribing certain of the Society's publications into the new spelling & for so transcribing one of Poe's tales. Details as to the form & manner of publication of pamphlets in the new spelling were left to the officers of the Society.

It was unanimously resolved that Professor Rippmann be asked to prepare a Spelling Book. The question of the publication of standard works, or reflections of them, in the new spelling was left over until a financial statement ~~is~~ was before the Committee.

It was decided to publish a leaflet as the first number of the Society's journal, about the middle of March, 1912; and the Professor Rippmann be desired to accept the editorship.

The Committee approved of the holding of an Essay competition in the summer of the present year. The suggestion was made that the subject be: " The Educational Advantages of Simplified Spelling" and that three prizes of fifteen guineas each be awarded as follows: one to men teachers, one to women teachers, one to the general public, for the best essay in each class. A second prize was suggested, but exact details & conditions for the whole competition were left over for consideration for the whole competition at a later meeting.

It was resolved that the next meeting of the Committee be held at 4.15 p.m. on the 15 th February, & thereafter on the second Thursday of each month at the same hour.

It was agreed on the motion of Mr. Archer, seconded by Mr. Daniel Jones, that the sum of £5 (five pounds) paid by Mr. Walton as a fine for not working out his notice at the Harrow County School should be refunded to him.

Mr. Archer moved, and Miss Gavin seconded that in future cheques should be signed by the Treasurer, Professor Rippmann, & Mr. A.R. Pollard, instead of by Professor Rippmann & Mr. Archer.

Attention was drawn to the rule that no payment of a sum exceeding ten pounds should be made without the special sanction of the Committee.

The printing in leaflet form of Mr. Archer's article in the "Daily Mail" of Febry. 7 th, 1912 was authorised. The Secretary was instructed to procure printed slips of neat design for attaching to letters and indicating that the spelling was in accordance with the proposals of the Society.

Professor Rippmann spoke in regard to the resolution passed at the last meeting of the Committee and desiring him to proceed with the preparation of a spelling book. He urged that the proposal was premature, inasmuch as the Scheme of Simplification was tentative and not final.

It was agreed that the matter be left in abeyance for the present.

The Treasurer submitted a financial estimate for 1912. It was as follows:

The Treasure explained that it was impossible to estimate many of the items with any degree of exactitude, seeing that this was the first year in which the expenditure was being incurred. The budget was approved.

The Secretary submitted a list of suggested conditions for the Essay Competition.

The following were approved:

- (a) The prizes to teachers to be restricted to teachers in schools.
- (b) The Competition to be open to all British Subjects & to foreign members of the Society.
- (c) Essays to be written in English and not to be more than 5,000 words in length.
- (d) The subject of the Essay may be interpreted in its widest sense.
- (e) Essays to be delivered to the Secretary on or before the first day of October, 1912; non-European competitors may have until the first day of November, 1912.
- (f) The prize essays to become the property of the Society.

Professor Rippmann gave an outline of the proposed first number of "The Pioneer". On the proposition of Mr. Pollard, it was agreed not to print in the "Pioneer" a list of the members of the Society.

Mr. Archer proposed and ~~Professor~~ Mr. Stanley Jevons seconded that Messrs. Harrisons' account for printing for January, 1912, be paid. The account amounted to £ 19·16·3.

Miss Gavin raised a discussion on the difficulties that children may meet in the Scheme of Simplification proposed by the Society.

The minutes of the last meeting were read and signed.

Mr. Archer suggested that Miss Gavin communicate to the "Pioneer" the views she expressed in the discussion at the last meeting on difficulties that children may meet with in learning the scheme of Spelling proposed by the Society.

The Secretary reported that 26 new members had enrolled since the last meeting, 13 as Full and 13 as Associate Members. The following donations had been acknowledged:

Mr. Archer raised a discussion as to the enrolling of without fee of all who are interested in the movement for Reform of Spelling, "signers" as they are called in America. The matter was left in abeyance.

Letters were read from Sir Edward Clarke & Professor Wyld and the Secretary was instructed to send to the latter a note of regret on his withdrawing from the committee of the Society. It was announced that Mr. Archer had already written to Sir Edward Clarke expressing regret at his resigning ~~from~~ membership of the Society.

The Secretary gave a summary of a leaflet he had drafted on the question of local branches. It was understood that it would be published in the "Pioneer".

A discussion took place in regard to the publication of general articles in Simplified Spelling and Professor Rippmann intimated that he might be able to approach Mr. H.G. Wells & secure permission for the publication of one of his stories. The Committee gladly gave authority.

Mr Archer proposed that preference be given to the phrase "rational spelling" rather than "simplified spelling" in the letters and publications of the Society on the ground that "simplified" suggested a partial and not complete reform. It was understood that such preference would be given.

On the proposal of Mr. Archer the Full Membership fee for members of the Canadian Branch of the Society was fixed at a dollar a year.

The Secretary was instructed to see the Secretary of the Bible Society in regard to the suggestion of Canadian members to publish one of the Gospels in rational spelling.

As the next meeting of the Committee was due to fall in Easter week, the Chairman suggested that it be left to the officers of the Society to decide whether it were necessary to call the meeting until the following month. This suggestion was agreed upon.

The Committee gave permission for the purchase of a new typewriter.

The Secretary was asked to attend the N.U.T. Conference at Hull and watch the interests of the Society.

Mr. Jevons was desired, on the suggestion of Mr. Archer, to interview the landlord from whom the offices are rented & see if he would bear part of the cost of renovation.

Minutes of a Committee Meeting held at 44, Great Russell Street, London W.C., on Thursday afternoon May 9 th, 1912 at 4.15.

There were present: Miss Walker (in the chair), Miss Gavin, Mr. Jevons, Mr. Pollard, Professor Rippmann.

The minutes of the last meeting were read and signed.

The Secretary reported that 66 new members had joined since the last meeting of the Committee and 4 old members had rejoined. A financial statement was read by the Secretary; it showed a balance of £ 67 on the current year (to December 1912) apart from £ 100 deposit from Life Members' subscriptions paid up to the beginning of the present year. The estimate did not take into account the fees for Life Membership paid during the current year.

A letter from Dr. Bradley to Mr. Archer was read, in which he expressed his desire to sever his connection with the Society. On the motion of Miss Walker it was agreed that Professor Rippmann try to have an interview with Dr. Bradley.

A letter was read from the Reverend J. Knowles, of Eastbourne, who suggested the adoption of a phonetic alphabet for optional use along with the present scheme of the Society and an appeal to members of Parliament for the appointment of a Commission to consider the question of a phonetic alphabet. Professor Rippmann moved that the Committee express its sympathetic interest in the proposal of Mr. Knowles, but that it did not see its way clear at present to embark upon a further campaign. This was agreed to.

A letter from Professor Mark Hunter, of Madras, reporting steps towards the formation of a large branch of the Society in South India, was read. It was agreed that Messrs. Higginbotham and Co., Booksellers, Madras, be supplied with 500 copies of the 6d booklet on Simplified Spelling, & other literature on the trade terms arranged by Professor Hunter; Mr. Pollard moving and Professor Rippmann seconding a resolution to this effect.

Professor Rippmann reported that Mr. H.G. Wells had given the Society permission to reprint one of his short stories, "The Star". The Secretary was instructed to secure estimates to present at the June meeting of the Committee.

The Secretary reported that the Bible Society was unwilling to enter into negotiations relative to the printing of one of the Gospels in Simplified Spelling.

A letter was received from the Secretary of the Committee appointed to make arrangements for the Celebration of the Pitman Centenary in January of next year. Professor Rippmann suggested that the letter be suitably acknowledged.

A letter was read from Mr. H. Drummond of Hetton-le-Hole, suggesting an Essay Competition for children. Miss Gavin moved and ~~Mr.~~ Mr. Pollard seconded that the idea be not entertained.

On the motion of Mr. Pollard, seconded by Professor Rippmann, it was agreed to ~~make~~ give a remuneration of £ 5 to Mr. Drummond for the books and tracts dealing with Spelling Reform which he had sent for the Office Library.

Professor Rippmann introduced a discussion in regard to the retention of final -y. His proposal to print an early number of the "Pioneer" with final -i instead of -y was agreed to as an experiment. On the motion of Miss Gavin it was further decided that a printed postcard be sent to each member with that particular number of the "Pioneer" so that a vote one way or the other might be recorded.

On the motion of Mr. Jevons it was agreed that the wages of Miss Montagu, the Junior Typist, be increased forthwith to 12/6d per week. It was further agreed that a sum of not more than £ 3 be spent on the purchase of an office table or equivalent.

Minutes of a Committee Meeting held at 44, Great Russell Street, W.C., on Thursday afternoon June 13th, 1912 at 4.15.

There were present: Mr. A.W. Pollard (in the chair), Miss Walker, Professor Rippmann.

The minutes of the last meeting were read and signed. The Secretary reported that sixty-four members had paid their fees since the last meeting of the Committee; of these 24 were old members and 40 were new.

Professor Rippmann reported his interview with Dr. Bradley and the Committee heard with regret that there was no possibility of retaining Dr. Bradley as a Vice-President of the Society.

The quotation of £ 15 (Fifteen pounds) from Messrs. Turnbull & Spears, Edinburgh, for printing 5,000 copies of the short story by Mr H.G. Wells was accepted on the motion of Mr. Pollard, seconded by Miss Walker.

On the motion of Miss Walker it was resolved that a letter setting forth the work of the Society during the past six months be sent to Mr. Andrew Carnegie. The Hon. Treasurer & the Secretary were instructed to draft the letters.

It was decided to ask the Committee of the Imperial Teachers Congress to allow the Society to be represented. The Secretary's suggestion to send literature to the delegates attending the Imperial Universities Congress was approved.

The Secretary was instructed to acknowledge Dr. Trenchman's list of suggestions for the improvement of the Society's scheme of rational spelling. It was understood that Professor Rippmann would make a further report upon the matter.

The Secretary was asked to secure estimates for "simplified spelling" note-papers for selling to members of the Society in accordance with the suggestion of Mr. E.A. Cave, of Uxbridge.

The Committee approved of the granting of three weeks holiday to Mr. Skeat & Miss Lock and a fortnight to Miss Montagu.

The offer of Mr. Stanley Jevons to allow two of his articles on "Industrial Unrest" to be reprinted in simplified spelling and in pamphlet form was received with interest; but it was felt that financial limitations precluded acceptance at the present. The opinion was also expressed that the Society ought to be cautious in regard to printing anything that might be in the nature of public controversy.

Minutes of a Committee Meeting held at 44, Great Russell Street, W.C., on Thursday, October 10 th, 1912 at 4.15 pm.

Miss Gavin, Mr. Stanley Jevons, & Mr. Daniel Jones were present. Mr Jevons was voted to the chair.

The minutes of the last meeting were read and signed.

The Committee desired to place on record their deep regret at the death of Professor Skeat & their appreciation of his life and work. The Secretary was instructed to send a letter of sympathy to the bereaved family.

It was reported that 219 new members had joined the Society since the last meeting.

A letter was read from Mr. Carnegie announcing his intention of visiting "the friends of improved spelling in London in the spring". The Secretary was requested to acknowledge Dr. G. B. Hunter's promised gift of £ 100 towards general expenses & to ask him to become a member of the Committee.

Mr. Jones proposed and Miss Gavin seconded that Dr. Alfred Marshall, Mr. J.L. Paton, & Miss Cleghorn be invited to become Vice-Presidents of the Society. The Secretary announced that Mr. H.G. Wells had provisionally ~~arr~~ consented to become a Vice-President. It was agreed that a formal invitation be sent.

The result of the plebiscite on final 'y' and final 'i' was given. 44 votes were cast in favor of the former, 100 for the later. Mr. Jones moved and Miss Gavin seconded that final 'i' be adopted.

Miss Walker, Professor Rippmann, & Mr. Jones were appointed judges in the Essay Competition. The rate of remuneration was fixed at 2/6 (two shillings and six pence) a script.

On the motion of Miss Gavin, the omission of the portion entitled "Partial Adoption of the Scheme for Provisional Use", page 10 of the Prospectus, from further copies was decided upon. It was agreed that the printed form of application for membership be more generally worded, so as not to commit a candidate to any particular scheme of spelling.

A letter of appreciation of his work was ordered to be sent to Mr. Mark Hunter, the Hon Secretary of the South Indian branch. It was reported that Mr. Daniel Jones was visiting India this year. Mr. Jevons moved and Miss Gavin seconded that he be asked to lecture in as many centres of India as possible at the fee fixed for lectures in this country; and that he be asked to bring back a report as to the movement in India.

On the motion of Mr. Jevons it was agreed that New Year's cards be printed instead of Calendars for 1913; and that the members of the Society be asked to buy these cards.

A conversation arose as to the form of printing & advertising for 1913 & the Secretary was asked to secure further details for the next meeting.

It was decided to rescind the resolution of the last meeting in regards to the omission of page 10 of the prospectus of the Society, and to omit the headline "Partial Adoption of the Scheme for Provisional Use" only.

On the motion of Professor Rippmann it was agreed that the resolution regulating the payment of articles in the Press be altered so^ as to read "not more than 1½ guineas for 1,000 words".

Professor Rippmann moved & Miss Walker seconded that the Society be affiliated to the Workers' Educational Association & a subscription of a guinea a year be paid.

Miss Gavin proposed that Mr. J.L. Paton be asked to represent the Society at the North of England Educational Conference in January 1913.

A letter from Mr. W.W. Skeat, the Corresponding Secretary, was read, but his request for an increase of salary from £ 96 to £ 150 per year was not acceded to. It was resolved that Miss Montague, the Junior Typist, be paid 15/- (fifteen shillings) a week from date.

After conversation it was agreed that '-ij' be the spelling of 'age' in such words as 'language'; and that the members of the Society be asked to vote as to the representation of 'ate' in words like 'private'. It was agreed that the spelling of the vowel sound in 'tune' be 'yu' both in strest and unstrest positions.

The Secretary reported that 139 new members had joined the Society since the last meeting of Committee. The list of names included Lord Avebury, Mr. J.K. Caird, of Dundee, & Mr. Alfred Pitman. The income from November 14 th to date amounted to £ 83·18·10, including a donation of £ 50 from Mr. Walter Morrison which the Secretary was asked to suitably acknowledge.

After explanation by Professor Rippmann, Mr Stanley Jevons Mr. Stanley Jevons moved and Dr. Hunter seconded that 2,000 reply paid post-cards indicating Arguments For and Objections Against rational spelling be printed and issued. Miss Walker moved that Miss Montague's wages be increased to 17s/6d per week beginning with the New Year; and this was carried unanimously.

Professor Rippmann moved & Miss Gavin seconded that Mr. W.H. Thompson be elected a member of the Committee.

Mr. Stanley Jevons moved & Miss Gavin seconded that Mr. Archer be asked to write to Mr. Carnegie in regard to the definite date of his visit to London.

A medical certificate was read in which it was stated that the health of Mr. W.W. Skeat, the Corresponding Secretary, was such as to necessitate a prolonged rest. It was agreed that the Secretary see Mrs. Skeat & inform her that the Committee was willing to grant a holiday of three months to Mr. Skeat, but that owing to the financial limitations his the Committee regretted that the post of Corresponding Secretary must cease at the end of that time.

The rezoluushon woz carid yunanimusli. A leter from Mr. W. J. Shield, ov Liverpool, woz red & in respons & in respons tu the recwest for a 'Reeder' for teeching the nyu speling tu yung children, it woz dezieded on the moeshon ov Mr. Jones seconded bi Mr. Archer tu print & publish 250 copiz ov a 16 paig 'Reeder', the mateerial tu be provided bi Mr Jackson.

On the moeshon ov Dr. Hunter it woz agreed that a grant ov £ 25 be maid tu the South Indian Braanch ov the Sositati for the purposez ov printing & isyuing propaganda literatyr.

In a leter Mr. W. M. Metford(?) ov Toronto, anounst the probability ov the loecal braanch ov the British & Foreign Bible Society consenting tu publish wun ov the Gospels in the oeld speling but with the nyu interlievd. On the moeshon ov Mr. Archer it woz reyzolvd that Mr. Metford be thanct for hiz generositi & enterpriez in maicing this publicaishon posibl; & that permishon be given tu yuz 'dh' tu represent wun ov the tuu soundz represented bi 'th' in the current speling, the permishon tu aplie tu this publicaishon oenli.

Dear Sir

The Simplified Spelling Society has for the past ten years urged the importance of a reform of English Spelling. Its efforts have met with extensive and weighty support, but during the five years of the war they were necessarily restricted. Now that peace has been restored the Society desires to press the claims of spelling reform with renewed vigour, as this reform appears more desirable even than before.

The war in enhancing the prestige of the English-speaking peoples has exalted the English language, and there is a wide-spread desire to learn it in all foreign countries. Further, the danger arising from ill absorbed alien elements within the Empire and in the United States of America has shown the national importance of a knowledge of English as a first condition of good citizenship. While English has the great advantage of a simple grammar, a rich vocabulary, and a magnificent literature, its acquisition is rendered unnecessarily difficult by its spelling, which, with its redundancies and inconsistencies, repels the learner, and affords him no trust-worthy guide to the pronunciation. The serious effects on our own children, by wasting their time and perverting their reasoning powers, need not be stated in detail; those engaged in teaching the young, especially in elementary schools, know them well.

Efforts have been made to solve the problem of spelling our language in a reasonable way, both in this country and in America; much spadework has been done. The Simplified Spelling Society are convinced that the time is ripe for the whole question to be considered by an authoritative body; and they know of none better fitted for this task than the British Academy. They therefore beg you, as its Hon. Secretary, to submit this letter to your Council, in the confident hope that it will receive consideration.

It is suggested that the most profitable procedure would be to arrange for a conference representative of the Empire and the United States, and that the reasoned report of this conference should be submitted to the respective Governments, with a view to official action.

A Meeting of Members of the houses of Parliament was held in a Committee Room in the House of Commons on March 31st which was addressed by Professors Gilbert Murray and Walter Ripman, there was only an attendance of 50 owing to various other meetings being held at the same time but the meeting has been of good value for propaganda purposes and has caused the subject to be talked over by Members, it is hoped to have another Meeting some time in June to be addressed by other speakers.

A letter signed by many prominent personages was promoted and was published in the "The Times" on Febry 22nd 1936, a correspondence was carried on for some time which has been very valuable in having the subject ventilated.

A further letter containing additional signatures was handed to the Press Associations and has appeared in several papers and a daily correspondence on the subject has been carried on particularly in "The Daily Telegraph" which is also causing Spelling Reform to be more widely discussed.

Several Rotary Clubs have been addressed on the subject and in this respect we feel indebted to Mr. T. Kingdom, Headmaster of Wyggeston Grammar School, Leicester, who has spoken on the subject to Leicester Sheffield and Ilkeston Rotary Clubs and is due to speak on July 2nd to Luton Rotary Club, this is useful work and may lead to the Society obtaining the support of "Rotary International" to the Memorial.

The Secretary read the first resolution on the notice of meeting as follows:-

The minutes of the Committee meeting held on May 11th 1936 wer read by the Secretary and it was proposed by Mr. Drummond, seconded by Mr. Roberton and carried that same be signed by the Chairman.

An apology for non-attendance owing to illness was read by the Secretary from Mr.G.H.Richardson.

The confirmation of the addition of Pro. Henry Martin, M.A., to the Committee was proposed by the Chairman and seconded by Mr. Drummond and carried unanimously.

The Chairman referred to the great loss to the Society by the death of the Chairman Sir George B.Hunter,K.B.E.,D.Sc.,and it was proposed by the Chairman, seconded by Pro.Jones that the following resolution be recorded in the minutes:-

"THAT the Committee of the Simplified Spelling Society desire to place on record their deep gratitude for the great and long continued services to the cause of Spelling Reform of the late sir George B. Hunter,K.B.E.,D.Sc.,during his tenure as Chairman of the Society and their profound regret at his decease; and they desire that this resolution be recorded in the minutes". The Secretary was asked to send a copy of this resolution to the relatives.

The Secretary read the following statement relating to the finance of the Society:- In 1920 our late Chairman, Sir George B. Hunter, founded what is known to us as the "Hunter 1920 Trust", in this trust he put away a number of Debenture Shares in Messrs. Swan, Hunter & Wigham Richardson Ltd., also a number of Preference Shares in the same Company and a number of shares in the Wallsend Slipway & Engineering Co., for the benefit of the Simplified Spelling Society and other religious and Temperance Societies. The final distribution took place in July 31st 1930 the share of the Simplified Spelling Society being 1300 Swan & Hunter Debentures, 1,700 Swan & Hunter Preference and 440 ordinary shares in the Wallsend Slipway Co., as per the final balance sheet

certified by Messrs. Russell Mann & Co., the auditors. The 1,700 Preference Shares have been left in Swan & Hunter's also the 440 ordinary Shares in the Wallsend Slipway but the 1,300 Debentures in Swan & Hunters were redeemed and re-invested in the Northern and London Investment Trust on deposit @ 3 ½ %, receive this interest half-yearly, we receive 6% from the Swan & Hunter Preference Shares and last year the Wallsend slipway paid 6 % dividend, thus the investments of the Society in shares are as follows:- 1,700. S.H. & W.R. Cum, Pref. Shares of £1 each. 440 Wallsend Slipway ordinary Shares of 10/s. each., and £1,300 Northern Investment Trust Ltd., Deposit., the value of these investments at Dec., 31st 1936 being as per our balance sheet £4,126.0.0. The dividends received last year (1936) were as per our balance sheet:

In addition to the above Trust Sir George formed another Trust known as the Hunter 1922 "C" Trust, this trust is solely for the benefit of Spelling Reform, the original terms being for the Simplified Spelling Society or any other Society or Association having similar objects, to enable this to be for our Society only, Sir George after having taken legal advice called a meeting of the Committee of the Society in May last at which the following resolutions were passed (see special sheet) after these resolutions were passed Sir George stated that he would write to the Trustees of the Hunter "C" Trust and inform them of these decisions and ask for their approval (see special sheet with copy of Sir George's letter to the Trustees and their replies).

When we required cash to carry on I used to inform Sir George when we wanted it and he then wrote or telephoned to Mr. Elliott. Secretary of the Trust, stating what amount was required and he (Mr. Elliott) then sent a cheque to our bank (Messrs. Barclays); as we required money shortly after the death of Sir George I saw Mr. Elliott and we then arranged that a letter signed jointly by Mr. Drummond and myself would be all in order, this we did and Mr. Elliott then sent a cheque for £100 to our bank on Feb. 8th, thus the society is carried on financially by dividends, sundry subscriptions, and grants from the Hunter 1922 "C" Trust. The latter trust is due for distribution in 1938.

The 3 share certificates mentioned previously wer kept by Sir George in his safe in an envelope marked "Simplified Spelling Society" together with a copy of the Hunter 1922 Trust, after Sir George's death his Solicitor took these away with other papers so I got in touch with him, at an interview with him on Feb. 15th which Mr.Drummond also attended he informed me that the names on the share certificates were as follows:

S.H.& W.R. Ltd.,:- Sir Mark Hunter., Sir George B.Hunter,
and Miss Patricia Marley,
Wallsend Slipway:- Sir George B. Hunter and Miss Patricia

therefore as Sir George was the last surviving name of the certificates it woud be necessary for him to hold these until probate was granted also although he knew that the shares belonged to the Simplified Spelling Society it woud be necessary for me to prove to him that they belonged to the Society, as a matter of form, I told him I had ample proof but when I showed him the balance sheet of the final distribution of the 1920 trust he said that was all that was necessary, he then said it would be necessary for me to let him have death certificates for Sir Mark Hunter and Miss Marley, (these I have sent him, Feb.16th) also a resolution from this meeting giving 2 or 3 names and full particulars of those whose names we wished the shares tranferred to., might I suggest that the names of the Honorary Treasurer and Secretary, Mr.H.Drummond and Mr.T.H.Barber respectively, and who were appointed trustees at the last Committee meeting, be sent leaving the 3rd name to be added the one of the new Chairman when appointed in this way you will have on the certificates the names of the three trustees representing the Society. The Solicitor said we could get our own Solicitors to transfer the shares but he was quite willing to do so and it would be only a small cost, Mr. Drummond and I both agreed that as they were doing Sir George's affairs and had everything in hand it was best for them to do the work. The Chairman proposed that the statement be approved of and this was carried unanimously.

The Chairman proposed, Pro.Jones seconded, and it was carried unanimously that the names of Mr. Henry Drummond of Rydal Mount Hetton le Hole, Co. Durham, Retired Secretary, and Mr.Thomas F. Barber of The Grove, Walkergate, Newcastle upon Tyne, Secretary, be placed upon the share certificates of the Society.

The question of the new Chairman was then discussed, the names mentioned being Sir William Jowitt, Sir A. Flowers, Sir John Murray, Sir Francis Goodenough and Sir F. Gowland Hopkins. The Chairman asked Mr Sydney Walton to allow his name to be considered and Mr. Walton agreed to consider the matter.

The future of the Society was then considered, a long discussion took place nearly everyone present taking part and it was eventually decided that a sub-committee be appointed to consider the matter, those appointed to the sub-committee were Pro. Murray, Chairman, Professors Jones, Ripman, and Lloyd-James and Messrs. Pitman and Walton, this committee to meet to meet on March 23rd at 2.45 p.m. in the League of Nations Union Headquarters. Arising out of this discussion it was proposed by the Chairman and seconded by Mr. Allan that the subscription to the Society be 5/- per member and 20/- per Society or Association.

A letter from Mr Allan regarding the alphabet of the International Phonetic Association was discussed but no decision was arrived at.

There being no further business the meeting terminated at 4.15 p.m.

Pro. Gilbert Murray presided and in addition the following were present Professors Daniel Jones, W.Ripman, A.Lloyd-James, Mr. I.Pitman and Mr.T.R.Barber, secretary.

The Secretary tendered an apology for non-attendance from Mr. Sydney Walton owing to a very important engagement.

The Secretary reported that Mr.Walton greatly appreciated the honour of being asked by the Committee to allow his name to be nominated for the Chairmanship of the Society but regretted that owing to the pressure of business he could not give the time that would be necessary.

The Chairman then asked Mr. Pitman if he would accept the Chairmanship but Mr. Pitman replied that he also appreciated the honour but felt that he also could not give the necessary time and it was agreed that the question of a Chairman be left in abeyance Pro. Gilbert Murray stating that he would be very pleased to act as Chairman until one was appointed.

The Secretary then read suggestions for obtaining farther support for the Memorial to the President of the Board of Education asking for the appointment of a Representative Committee to consider English Spelling and also presented a report from the Patch Simplified Spelling Society showing how they worked and were successful in obtaining a Government Commission which recommended the adoption of several of the principal rules of the reform scheme and the feeling of the members present was where was a campaign that was successful and might be worked in this Country. The first point was "A definite program of simplifications as a basis" Pro. Jones pointed out that this was accomplished by the scheme drawn up by Pro. Ripman and Dr. Archer, Pro. Jones said he had a copy and also thought Pro. Ripman had a copy and it was agreed that Pro. Ripman and Mr. Pitman should meet and go over it with a view to publication.

Item No. 3 was propaganda by Pamphlets for free distribution and it was agreed that the Secretary should send to Pro. Ripman and Mr. Pitman copies of every pamphlet issued by the Society so that these gentlemen could go over same and see what could be done to bring them more up to date and report to the next meeting.

Item No. 4 was lectures to all classes of society, among other things to parents-meetings, this was agreed to.

It was thought that seeing that the Society may be making an appeal for financial support in the near future that an address in London would be more successful than an address in Wallsend.
